NOTE: Memberships that are frozen for ninety (90) days will be reviewed for termination, unless payment arrangements have been made. Members that are terminated will be considered "new" upon rejoining the Kenosha YMCA, and may be required to pay a joiner fee.

In the event you wish to change from EFT (Bank Draft or Credit/Debit card) to an annual payment plan, you must cancel your bank/card draft as stated in #1 above and then purchase the annual paid in full membership at the current rate. Please see the Kenosha Y Member Service Desk for assistance.

The Kenosha YMCA membership dues are subject to change; however in the event of this happening, you will receive written notice. The new prices would go into effect immediately beginning with the next draft.
